**Modified Vehicle:** A vehicle that has been changed from its original manufactured or "stock" condition. This includes changes in engine or drivetrain which were not available in the original manufactured year, increase in horsepower, or custom paint and/or decals. Generally, safety-related modifications such as steering, brakes or tires & wheels are not considered modifications.

Scores will be tabulated based on the following categories/criteria:

1. Exterior Condition: lamps, chrome, moldings & detailing
2. Exterior Paint: condition, cleanliness & presentation
3. Interior & Glass: Stereo equipment, dash, layout, coverings, specialty items
4. Engine Compartment: Inner fenders, fire wall, wiring, engine components
5. Wheels & Tires: condition, cleanliness & presentation


Dear Applicant:
